This Public Hearings will be held between the months of February and March 2020.

The purpose of these hearings is that every insured employer who wishes to do so, appear to present to present their proposals, allegations and experiences concerning the schedule of Classifications according to the occupations and industries, and their applicability in relation to the Workers Insurance Policies administered by the State Insurance Fund Corporation.

Article 21 of the Law 45 of April 18, 1935, Known as the **Workers Compensation Accident System Act**, provides that the Administrator shall prepare the schedule before July 1, of each year. In addition, Article 22 provides for the holding of public hearings.

We recommend you to attend the Public Hearings based on the town closest to the location of your company or business. Employers' contributions are extremely important in the achievement of a better performance of the welfare service of the Puerto Rican working class and the business sector .
